## **Terms and Conditions (trial period)**

### **1 For the purpose of this document:**

- 1.1 'The Company' is *Tempus Systems LTD*.

### **2 General**

- 2.1 The purpose of this is to document the procedures and Terms and Conditions set by The Company with regards to the Product provided.

### **3 Guarantees**

- 3.1 The Company guarantees the Product against faulty workmanship for the entire trial period from the date of supply.
- 3.2 These guarantees do not cover neglect, abuse or misuse of the Product, any damage caused directly or indirectly by dismantling, transit from the Client Premises, modification, loss and/or damage due to fire, smoke, water, lightening, weather, corrosion, theft, explosion, accidental damage and consequential loss.

### **4 Working Ethics**

- 4.1 It should be in the interest of both The Company and The Client to maintain a level of confidentiality with regards to all business conducted between the two parties.

### **5 Contract Details**

- 5.1 The Company will install the required Product at the Client Premises for a trial period as stated on page one of this document. At the end of the trial period all Product will be returned to The Company in the condition it was received.
- 5.2 Any Product returned damaged will be charged in accordance to the Company's list prices.
- 5.3 During the trial period all Product remains the property of The Company.
- 5.4 The Client will not incur any installation charges during the trial period, however if the Client should decide to purchase the Product usual installation charges will be applied.
- 5.5 The Client may not duplicate any software under any circumstances.
- 5.6 The Company will be responsible for all Product Support.
- 5.7 Faults or malfunctions must be reported by immediately to The Company.
- 5.8 All faults or malfunctions will be corrected free of charge, as long as the cause is not found to be the result of the reasons as detailed in 3.2 above.

### **6 Limitations**

- 6.1 The Directors of the Company reserve the rights to amend and or change this contract at anytime giving reasonable notice and in line with Company policy.
- 6.2 The Client has the right to terminate this contract for reasons where The Company does not comply with the terms of this agreement.
